## DISINFECTION / VIRUCIDAL / FUNGICIDAL / MOLD AND MILDEW CONTROL DIRECTIONS\*

Before using Foster® 40-80, familiarize yourself of all hazards and precautions by reading the product label and safety data sheet. Ensure user is wearing appropriate PPE for the application and hazards. Always follow directions on the label before using. If transferring Foster® 40-80 to a secondary container for application, make sure to label the secondary container with the product name for identification. Keep original container label for reference. \*These directions are intended for use on hard non-porous surfaces. Refer to the label directions for more information.

- 1. CLEAR EXTRA FILTH.** For heavily soiled areas, complete a preliminary cleaning by removing gross filth or heavy soil so that the surface is clean and the disinfectant can effectively saturate the substrate.
- 2. DO NOT DILUTE.** Foster® 40-80 is ready-to-use, so no dilution is necessary.
- 3. APPLICATION METHODS.** Apply Foster® First Defense™ undiluted to hard, non-porous surfaces, thoroughly wetting the surfaces with a cloth, mop, sponge, sprayer or by immersion. For sprayer applications, use a coarse spray device. Spray 6-8 inches from surface; rub with brush, sponge or cloth. Avoid breathing spray.

## PRECAUTIONARY STATEMENTS

### HAZARDS TO HUMANS AND DOMESTIC ANIMALS
